3.    **Rural County Grant Update – Jeff Jones**

On September 1, 2020, Summit County made application to the Utah Governor's Office of Economic Development for a Rural County Grant in the amount of \$95,833. Summit County was notified of its award on Friday, September 11<sup>th</sup>. By accepting Part A grant money for FY 2021, the County acknowledges that future

grant funding under Part A will be contingent on County's **timely reporting** as required under Utah Code § 17-54-103(9) and the demonstration of the tender of matching funds in the amount required by Utah Code § 17-54-103(5). If the County fails to comply with any law applicable to the issuance of this grant money or makes any misrepresentation in this application, the State may, in its sole discretion, deny this application or future applications submitted by the County.

**ACTION:** Direct staff to prepare a funding guide, application process and timeline in support of both the Outdoor Hospitality Services Grant and the Small Business Development Grant.
