



## NOTICE OF ELECTION

### 2022 REGULAR GENERAL ELECTION

In accordance with Utah Code Annotated § 20A-5-101, the following is a list of the offices to be filled at the regular general election to be held in the State of Utah on Tuesday, November 8, 2022.

#### 1. FEDERAL

- a. **U.S. Senate.** One (1) Senator for six (6) year term.
- b. **U.S. House of Representatives.** One Representative for a two (2) year term in the First and Third U.S. Congressional Districts, each of which incorporates a portion of Summit County.

#### 2. STATE

- a. **State Executive.** The following position will be elected for a two (2) year term to fill the remainder of a vacancy:
  - i. State Treasurer
- b. **State Senate.** One member for a four (4) year term for Senate District 20 incorporating part of Summit County.
- c. **State House of Representatives.** One member of the Utah House of Representatives for a two (2) year term from District 4, 23, 59, & 68.
- d. **State Board of Education.** One member for a four (4) year term from State School District 1, 6.

#### 3. JUDICIAL

- a. **Supreme Court.** There will be a retention election for one (1) Supreme Court Judge, provided that the incumbent whose term is expiring files during the filing period.
- b. **District Court.** There will be a retention election for fifteen (15) District Court Judges in the Third District, which includes Summit County, provided that the incumbent(s) whose term is expiring files during the filing period.



- c. **Juvenile Court.** There will be a retention election for one (1) Juvenile Court Judge in the Third District, which includes Summit County, provided that the incumbent(s) whose term is expiring files during the filing period.

#### **4. COUNTY**

County offices up for election for four (4) year terms are:

County Council Seat D  
County Council Seat E  
County Attorney  
County Auditor  
County Clerk  
County Sheriff

#### **5. LOCAL SCHOOL BOARD**

Local School Board seats four (4) and five (5) are up for election for four (4) year terms in:

Park City School District  
North Summit School District  
South Summit School District

The Declaration of Candidacy filing period for qualified political party candidates begins on Monday, March 7, 2022 and ends at 5:00 p.m., Friday, March 11, 2022.

The Declaration of Candidacy filing period for local board of education candidates begins on Monday, March 7, 2022 and ends at 5:00 p.m., Friday, March, 11, 2022.

The Declaration of Candidacy filing period for justices and judges of a court of record begins Friday, July 1, 2022 and ends at 5:00 p.m., Friday, July 15, 2022.

The Declaration of Intent to Gather Signatures period for qualified political party candidates begins on Monday, January 3, 2022 and ends at 5:00 p.m., Friday, March 11, 2022.

Qualified political party candidates must submit nomination petition signatures no later than 14 days before the day on which the qualified political party holds its convention to select candidates for the elective office.
